ADDITIONAL PICK/ DROPS ~	Per occurrence charge of \$85.00 will apply.
AFTER HOURS DELIVERIES ~	All pickup or deliveries will be completed within regular business hours of 8 AM to 5 PM. All pickup/deliveries after before or after these times will be subject to a per shipment fee of \$100.00.
APPOINTMENT DELIVERY ~	Per Shipment charge of \$55.00 This fee will apply when a shipment requires a specific appointment time of delivery. The BOL (Bill of Lading) must reference the prearranged time of delivery.
ATTEMPTED PICKUP ~	Per occurrence charge of \$85.00. This fee will apply when an attempt at delivery was unsuccessful or one of the following occurs: <ul style="list-style-type: none"> • Shipper requests we pick up at another time. • There is no answer at the shipper. • Shipper requests we pick up at another address within the servicing terminals area which was not originally noted on the Bill of Lading.
BILL OF LADING ~	A separate Bill of Lading must be issued for each shipment and cannot include more than one consignee and or destination. A Bill of Lading MUST include the following: <ul style="list-style-type: none"> • Name of Consignor • Name & address of consignee • Origin of the shipment • Destination of the shipment • Date of the shipment • Name of originating carrier • Description of goods, pallet count, piece count and weight • Declared value of shipment, if applicable • Whether shipment is prepaid or collect • Any special agreements, if applicable • Acknowledgement of the goods being received in good condition.
BLIND SHIPMENTS ~	Per shipment charge of \$50.00
BOND CHARGES ~	Per shipment charge of \$150.00 minimum
BORDER CROSSING FEE ~	1 (one) hour free. Any additional time thereafter will be charged at \$85.00 per hour.

CALL FOR DELIVERY ~	<p>Per Shipment charge of \$25.00.</p> <p>This fee will apply when the carrier is requested to notify the consignee prior to delivery. This charge will also apply if the Consignee makes the request.</p>
CARRIER LIEN ~	<p>McKevitt Trucking LTD. may retain possession of goods being shipped, as a lien, until payment has been made on that shipment OR to bring the customer's account to good standing. After taking possession, the customer will be given 15 days to pay, or the product will be disposed of and any proceeds will then be applied to the outstanding debt.</p>
CARRY IN CHARGE~	<p>Per shipment charge of \$5.00 per CWT Minimum ~ \$35.00 Maximum ~ \$275.00</p>
CHANGE IN TERMS – BILL OF LADING ~	<p>Per shipment charge of \$20.00 This fee will apply when there are changes to a change in the terms of the Bill of Lading ie. prepaid to collect, re-consignment or 3rd party.</p>
CLAIM LIABILITY ~	<p>Liability for loss or damaged will be based on the lessor of \$2.00 per pound or the cost of the goods. The liability is based only on the actual weight of the lost or damaged freight with a minimum of \$50.00 and a maximum of \$50,000.00 per shipment.</p> <p>Claims will be denied on freight not properly addressed or labeled with the consignee's name and address.</p> <p>Any shipment that is hanging over a skid will be considered inadequately packaged for shipping and claims will be denied.</p> <p>Claims must be submitted in writing within 60 (sixty) days of the delivery and must include the customers invoice, supplier invoice and a copy of the delivery bill confirming the damage/shortage. Claims must be submitted by email to claims@mckevitt-trucking.com</p> <p>Any excess valuation over \$2.00 per pound will be charged at 2% of the excess, with a minimum charge of \$40.00, on any shipment showing a valuation. Additional insurance is available for shipments having excessive value.</p>
COD ~	<p>\$30.00 minimum charge for COD up to \$333.00. For any COD over that would be subject to a fee of 6% of the COD amount.</p>
CONSTRUCTION SITE ~	<p>Per Shipment charge of \$85.00</p> <p>This fee will apply when we pick up or deliver.</p>

COPIES OF DOCUMENTS ~	<p>This fee is applicable when additional copies of documents are requested AFTER being sent originally.</p> <ul style="list-style-type: none"> • Copy of Invoice ~ \$2.00 per copy. • Copy of BOL ~ \$5.00 per copy. • Copy of POD ~ \$5.00 per copy. <p>Other supporting documents ~ \$5.00 per copy</p>
CREDIT CARD PAYMENTS ~	<p>All payments made by credit card will be subject to a 3% fee. This fee will apply to the full invoiced amount including additional fees and taxes.</p>
CUBE (DENSITY) ~	<p>All shipments are subject to a minimum density of 10 lbs. per cubic foot and will be according to the prevailing tariff.</p> <p>Any freight that cannot be top loaded is subject to a minimum height of 8'.</p> <p>Any shipment 10' or more is subject to a minimum weight of 1000 lbs. per lineal foot.</p> <p>Shipment that prevents the loading of freight above, beneath and/or around due to size, shape, construction, or other inherent characteristics will be charged on the basis of cubing the shipment to the roof of the trailer (minimum 96")</p> <p>The greater of the actual or cubed weight will be used for rating purposes.</p>
DANGEROUS GOODS ~	<p>Per shipment charge of \$40.00</p>
FLOWERS & PLANTS ~	<p>Shipments consisting of flowers & plants will be shipped at owner's risk of damage and loss.</p>
FUEL SURCHARGE ~	<p>McKevitt Trucking is compelled to charge a surcharge on diesel fuel exceeding 0.39 cents per litre. We monitor the Freight Carrier Association of Canada weekly and charge accordingly.</p>
HEATED STORAGE ~	<p>Per shipment charge of \$65.00 minimum per day OR \$2.05 per 100lbs after 24 hours including weekends and holidays.</p>
LABOUR CHARGES ~	<p>\$18.00 per 0.25 hours (minimum 4 hours)</p> <p>This fee will apply when a driver requires a helper to load or unload the freight. This is calculated based on the total time completing the task including travel time from the closest terminal.</p>
LAYOVER CHARGE ~	<p>\$350.00 per day</p>
LONG FREIGHT HANDLING ~	<p>Freight over 10' long, weighing more than 250 lbs. will be subject to cubing at a minimum of length X 48" X 48" will be charged a per shipment fee of \$85.00 PLUS applicable freight charges.</p>
MILEAGE CALCULATION ~	<p>Mileage is calculated using Rand McNally Software</p>

NO RIGHT TO OFFSET ~	The customer has no right to reduce any sum due to the carrier for any reason including but not limited to overpayment, weight disputes, shortages, damages, or loss from a separate shipment. The customer cannot deduct, short pay any amount that is due or past due to McKevitt Trucking LTD. As a result of unrelated disputes.
PALLET RETURNS ~	Rates do not include pallet returns unless agreed to.
PAYMENT TERMS ~	Payments are due 30 days from the invoice date, unless otherwise agreed to in writing. Late payments will be charged a late fee of 2% per month (24% per annum)
PROTECTIVE SERVICE ~	All shipments requiring heat are subject to a minimum fee of \$40.00 or 15% of the freight charges per delivery. All shipments that require reefer are subject to a minimum fee of \$45.00 or 18% of the freight charges per delivery.
QUOTES ~	All freight quotes are valid for 30 days.
RATE ESCALATION ~	Rates are valid for 1 (one) year from date of issue.
RE CONSIGNMENT ~	Per shipment charge of \$70.00 This fee will apply when the address as documented on the original bill of lading is changed to another address in the same servicing terminals area. This will require a new bill of lading to be issued.
RE-DELIVERY ~	\$4.67/CWT Minimum \$85.40 ~ Maximum \$285.00 This fee will apply when an attempt at delivery was unsuccessful or one of the following occurs: <ul style="list-style-type: none"> • Consignee requests to deliver at another time. • There is no answer at the consignee. • Consignee requests we deliver to a different address within the servicing terminals area which was not originally noted on the Bill of Lading.
REFUSAL OF SHIPMENT ~	If a shipment is refused by either the Shipper or Consignee it will be subject to the original freight charges plus any and all other charges.
RESIDENTIAL DELIVERY ~	Per Shipment charge of \$90.00 This fee will apply when we pick up or deliver at a private residence even if the business operates out of that location.
REWEIGHING OF SHIPMENT ~	Per shipment charge of \$15.00 Shipments that are reweighed will include the product container, packaging, pallet, or any other item attached to the shipment and will be included in the reweigh. Any Bill of Lading not matching the scaled weight will have an additional \$10.00 scale fee plus the charge of the extra weight.

SHIPMENT DELAYS ~	McKevitt Trucking will not be liable for any costs and/or fines as a result of shipment delays and does not guarantee their service unless agreed to in writing.
SHOPPING MALL ~	Per Shipment charge of \$85.00 This fee will apply for any pickup or delivery.
SMALL VEHICLE CHARGES ~	\$45.00 minimum OR \$65.00 per hour
STORAGE ~	Per shipment charge of \$25.00 minimum per day after 24 hours including weekends and holidays.
TAILGATE SERVICE ~	Per occurrence charge of \$45.00. This fee will apply for any pickup or delivery.
TAXES ~	All rates are subject to Harmonized Sales Tax (HST) if applicable.
TRADE SHOW ~	Per Shipment charge of \$100.00 minimum to \$350.00 maximum This fee will apply for any pickup or delivery.
TRAILER DEMURRAGE ~	\$150.00 per day after 24 hours
USED FREIGHT ~	Used, uncrated or inadequately packaged freight will be shipped at owner's risk.
WAITING TIME ~	Loading and/or unloading time is as follows. Any additional time will be charged @35.00 per 15 minutes. <ul style="list-style-type: none"> • 0-500 LBS ~ 15 Minutes • 501-10,000 LBS ~ 30 Minutes • 10,001-20,000 LBS ~ 60 Minutes • 20,001-30,000 LBS ~ 90 Minutes • 30,001- Truck Load ~ 120 Minutes
WEEKEND/ HOLIDAY DELIVERY~	Per shipment charge of \$350.00 will apply. Deliveries must be prearranged, in writing, through Thunder Bay Dispatch. Any holiday that falls on a Sunday, will be considered as falling on the following Monday. The following days are considered Holidays: <ul style="list-style-type: none"> • New Year's Day • Family Day • Good Friday • Canada Day • Victoria Day • Civic Holiday • Labour Day • Thanksgiving Day • Christmas Day • Boxing Day
